

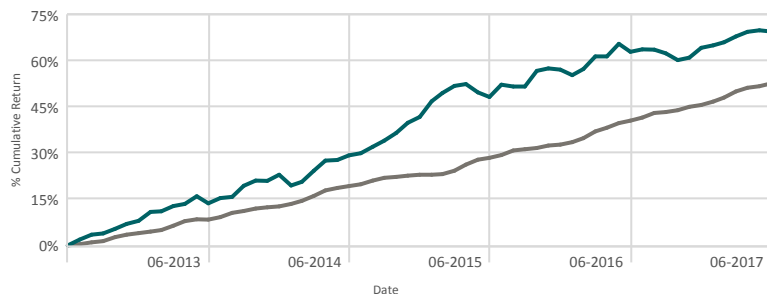
+ INVESTMENT OBJECTIVE

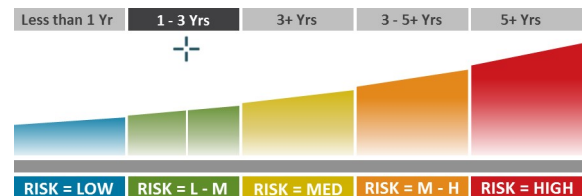

Low - Medium Risk
