

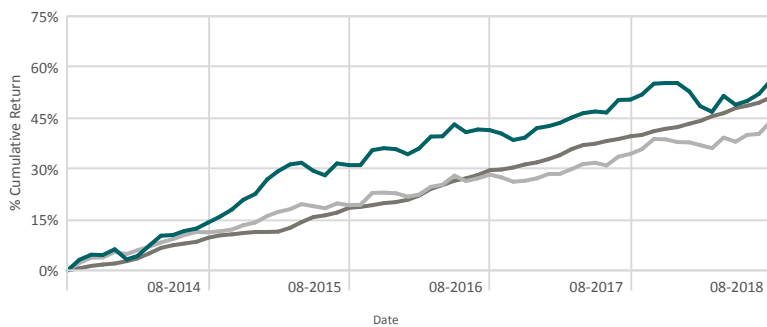
INVESTMENT OBJECTIVE

INVESTMENT UNIVERSE

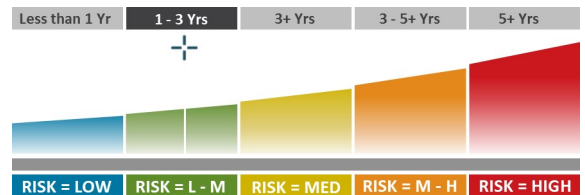

Low - Medium Risk
