



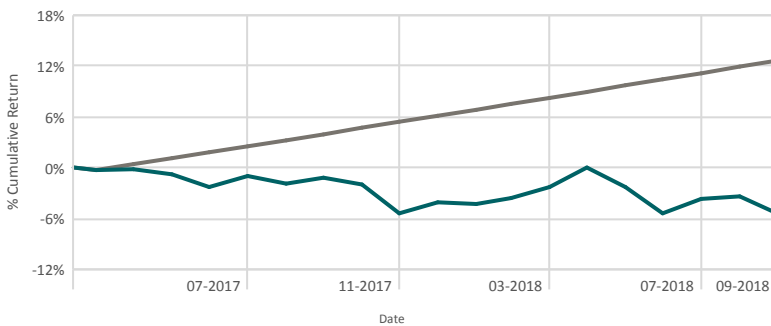
INVESTMENT OBJECTIVE

The investment objective of the Plexus Wealth BCI Flexible Property Income Fund aims to provide the investor with high income through investing predominantly in listed property securities and other high yielding securities.

INVESTMENT UNIVERSE

The investable universe of the portfolio will include equity and property securities, including companies that derive a material portion of their income from property investment, property collective investment schemes, property loan stock, interest bearing instruments and securities, preference shares, non-equity securities and assets in liquid form. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions for efficient portfolio management purposes.

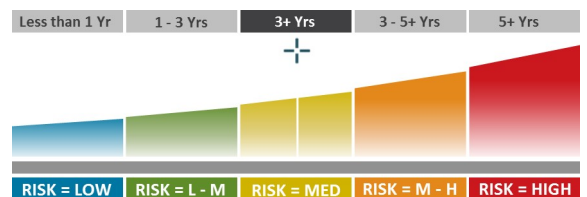
