

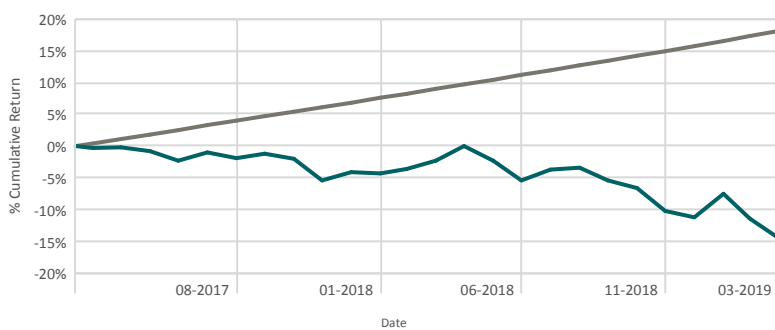
## + INVESTMENT OBJECTIVE

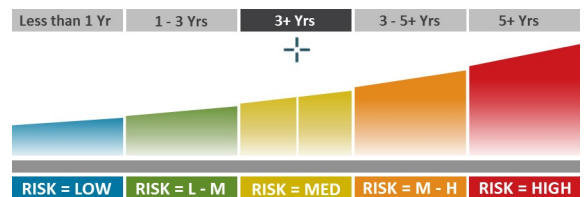
