

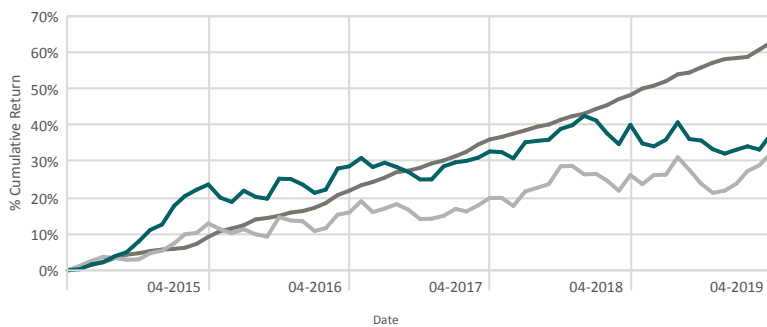
INVESTMENT OBJECTIVE

INVESTMENT UNIVERSE

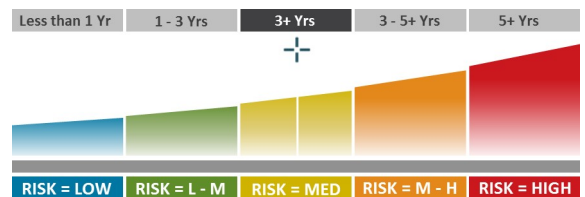

Medium Risk
