



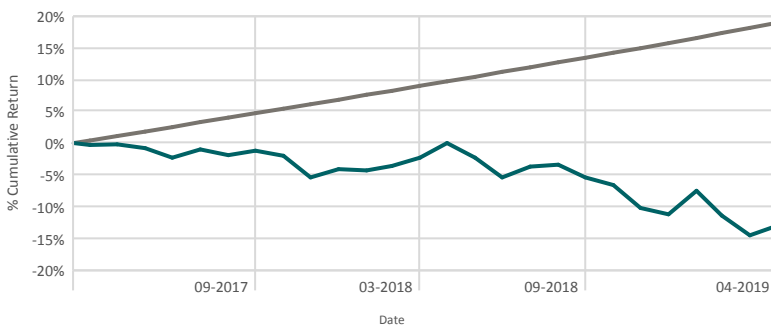
**+** INVESTMENT OBJECTIVE

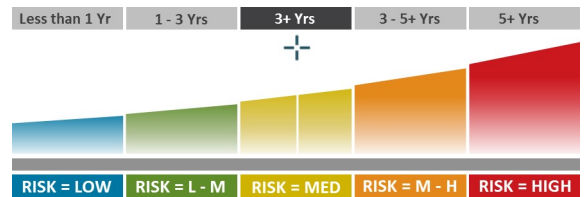
