### INVESTMENT OBJECTIVE

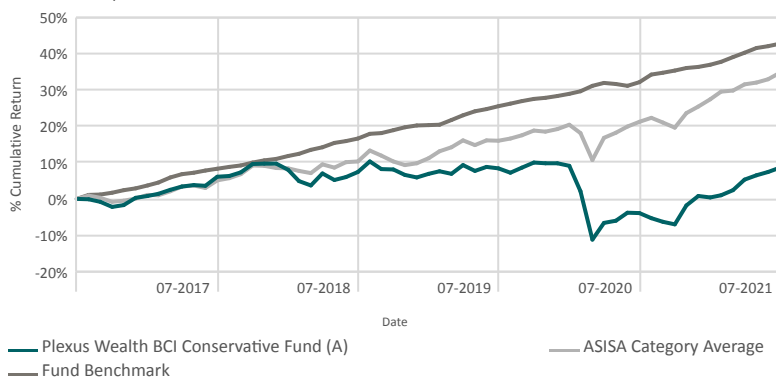

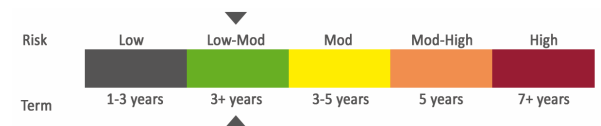
