

INVESTMENT OBJECTIVE

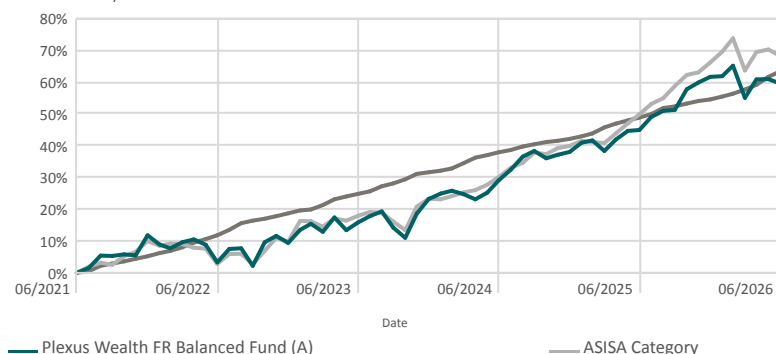
The investment objective of the Plexus Wealth FR Balanced Fund is to obtain long-term capital growth with some income at moderate risk levels.

INVESTMENT POLICY

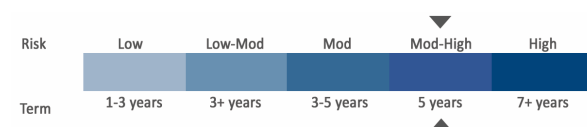
