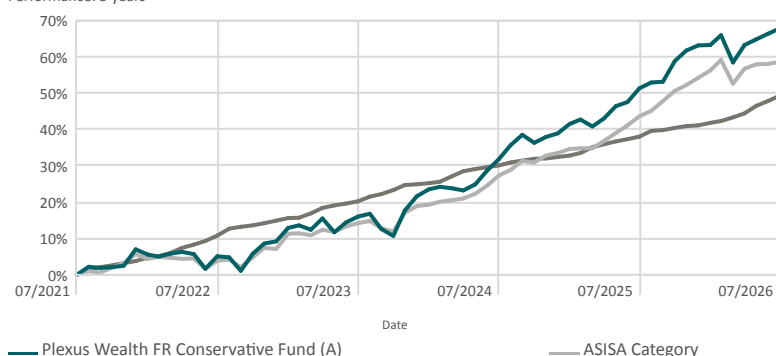

INVESTMENT POLICY

The portfolio may from time to time invest in listed and unlisted financial instruments.

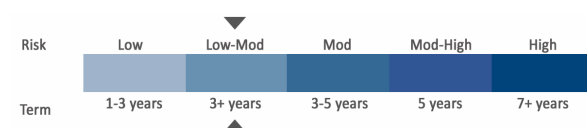
